IV. Reports

Entrance Lights

LED Light has been recently installed at entrance by Emmett Scharf Electric. LED light electric charge should be minimal.

Muskrats

The muskrat situation has been investigated by a Pest control company. The muskrats that were previously digging and living in the detention basin were no longer there. There was no charge by the Pest Company. Advised homeowners to notify board if they see any indication of muskrat return

Survey of common area

Discussed recent survey of common area surrounding the detention basin for the purpose of determining property lines prior to any erosion work being performed. Kent Jarrett – President indicated that he would be placing rebar in place of the sticks that are currently on the property lines and that he will be placing them deep enough for the homeowners to be able to mow.

Fence

Discussed current state of fence – with two panels missing and how we should repair and what we should do about future fence repairs should they be needed. The fence panels have been discontinued and are not available in Bloomington. The only panels available are located at the Menards in Wilmington IL. Discussed getting the panels from Wilmington but having to rent a truck to do so. Also discussed placing a wood fence behind the vinyl fence. There was no consensus – matter will be discussed further by the board and the homeowners.

Gate Painting

Discussed need to have gate painted due to the rust and peeling paint. We received an estimate from McGraw ornamental Iron - brought in by Mike Parker. Vicky Strauss - will contact McGraw for a more formal document and proof of insurance.

Mowing & Fertilizing contracts

Discussed current year contracts - price for mowing (Kim LeBaube mowing) will remain the same for this year. The price for fertilizing (Freedom Lawn Maintenance) has increased some for this year.

2 trees per lot

Discussed - covenant requirement of two hardwood trees per lot. See Article V, Section 12 of the Hershey Grove Covenants.

Planting in common areas

Discussed that a drawn up plan and approval by HOA board required prior to planting anything in the common areas of Hershey Grove. A document of understanding is to be created for further clarification. See Article V, Section 10 of the Hershey Grove Covenant.

VI. New Business

Discussed the cattails that grow around the detention basin. These are known to attract muskrats. There was discussion about spraying to kill the cattails, as cutting them down does not keep the muskrats away. It was indicated that it can take up to 5 years to kill the cattails. About 2 to 3 years ago some of the Homeowners along the detention basin got an estimate from a company called Marine Corporation to spray around the basin for \$300 to \$400. Instead of using this company at that time chemicals were purchased by the homeowners and a qualified person sprayed the affected areas. It was decided that since this was a problem in a common area that this service should be part of the HOA responsibilities. Vicky will check into prices for this service.

Millard Jorgenson – brought up information regarding our detention basin being the recipient of water flowing in from Brookridge Estates and Ireland Grove subdivisions and possibly causing some of the issues with our detention basin. He also provided a copy of the City of Bloomington Storm Water Credit Manual.

Kent took this information and will do some further investigation.
