## **Discussion Topics**

#### Financial Report -

- Pauline provided information regarding current HOA account balances and expenses via email.

- There are two houses currently for sale in the subdivision. One is new construction.

#### **Detention Basin** –

Sid has received a bid from Bio Chem for treatment to remove the water aquatic vegetation. We need
to decide if we are treating the above the water vegetation – bulrushes & cattails and/or the below the
water plant growth.

#### Dead Ash Trees on Berm

- Sid & Kent have requested bids for the removal of the 12 dead trees on the berm. Sid has received one bid for \$4000.
- The board also discussed the possibility of cutting down the trees on our own and renting a stump grinder.
- We will wait for the other bids before making any decisions.
- Also discussed how and when trees might be replaced in the future

#### **Covenant Violations**

It was decided to ask our attorney to create a template that can be sent via USPS to homeowners regarding covenant violations. We currently have violation concerns related to

- Front yard grass planting
- Parking of large trucks in the subdivision
- · Responsibility of mowing and maintenance of adjacent common area
- Signs on Common Areas

#### Trees & Bushes along Detention basin on Hershey

- We are 2 shrubs short from original drawing- a viburnum & a dogwood
- Pauline asked that we set up a walk through to review the current state of the trees and to discuss what is needed for maintenance of these plants.
- Sid has a call into Jason at F & W to discuss the missing plants. He will also request the walk through at that time.

• Kent has a call into Snyder to discuss the mowing situation
